1. Date of release of bids through e-Tender: **17th August 2016 (10.00 am)**
2. Availability of bid documents and mode of submission: The bid documents are available online on <http://uktenders.gov.in> since **17th August 2016**. The bidder would be required to register in the website which is free of cost. For submission of the bid online the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized certifying authorities. The bidders are required to submit (a) original demand draft towards the cost of bid documents (b) original bid security pledged in favor of Director, Department of Animal Husbandry, Uttarakhand, Dehradun (c) original affidavit regarding correctness of information furnished with bid documents as per provision of bidding documents (d) undertaking regarding validity of tender documents till the prescribed validity period duly signed on Rs. 100.00 stamp paper and revenue stamp of Rs. 1.00 affixed thereon with the Director, Department of Animal Husbandry, Uttarakhand on or before the date and time of opening of technical bid either by registered post or by hand. Failing which bid shall be declared non responsive.
3. Last date/time of receipt of bid through e-procurement is **2nd September, 2016 upto 02.00 pm**.
4. Earnest money shall be in the form of FDR/ Demand Draft/ Banker's Cheque or Bank Guarantee in favor of Director, Department of Animal Husbandry, Uttarakhand, Dehradun (to be valid for a period of 45 days beyond the original validity period of the bids).
5. Technical bids shall be opened on **2nd September, 2016 at 02.30 pm** by the prescribed committee.
6. Director, Department of Animal Husbandry, Uttarakhand, Dehradun reserves the right to reject any or all tenders without assigning any reasons thereafter.
7. All other relevant conditions of the tender process can be seen from the instructions to bidders (ITB) in bidding document.
