#### 2. **Bid**

- A] The bid shall be submitted along with **Bid Security** of Rs.14000.00 (Rs. - C] All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- D] Bid shall be accompanied with following documents:

#### 3. Preparation, Sealing and Marking of Bid:

The Bidders shall sign & stamp all pages of bid document and Seal the signed & stamped bid document in an envelope duly marking the envelopes as Invitation for Bid title and and a statement "DO NOT OPEN BEFORE11:30 AM.*ONO* 01.09.2020."

4. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

- 5. The price shall be quoted in Indian rupees only.
- 6. Each bidder shall submit only one bid.

### 7. Validity of Bid:

Bid shall remain valid for a period not less than 60 days after the dead line date specified for submission.

#### 8. Evaluation of Bids:

The purchaser will evaluate and compare the bids determined to be substantially responsive i.e. which

- A] are qualified as per the terms and conditions of bid document.
- B] Bids shall be evaluated on all item together basis.

Prior to expiration of the bid validity period office of Chief Veterinary Officer will notify the bidder whose bid is accepted for the award of contract. The terms of the accepted offer shall be incorporated in the purchase order.

- 9. Award of Contract: The office of Chief Veterinary Officer will award the contract to the bidder whose bid has been determined to be substantially responsive and who has offered the lowest evaluated price for each item. The successful bidder will have to sign the agreement on non judicial stamp paper of Rs.100.00 within 2 weeks, the cost of which (non judicial stamp paper) shall be borne by the successful bidder & shall have to submit performance security equivalent to 6% of the total value of order in the form of Bank Draft or FDR of any nationalized bank valid up to 60 days after the date of completion of performance obligations including warranty obligations. Bank Draft or FDR will be in favor of/ pledged to "Chief Veterinary Officer Pauri Garhwal" payable at "Pauri" within 2 weeks.
- 10. Liquidated Damage for Delays: The applicable rate is 0.25% per week and the maximum deduction is 10% of the contract price after that the contract shall be cancelled & the performance security deposited by the successful bidder will be forfeited. Non
- 11. **Resolution of Disputes:** In case of dispute relating to the enforcement of the provisions of agreement, Addl. Director, Department of Animal Husbandry, Garhwal Mandal, Pauri or his authorized representative shall act as arbitrator in the matter as per the provisions of the Arbitration Act of Government of India.
  - Any dispute arising out of this agreement will be settled under the jurisdiction of Pauri Court.
- 12. Not withstanding the above, the office of Chief Veterinary Officer, Pauri reserves the right to accept or reject any bid and to cancel the bidding process and reject all bids at any time prior to the award of contract.
- 13. The office of Chief Veterinary Officer, Pauri prior to expiration of the bid validity period will notify the bidder whose bid is accepted for the award of contract. The terms of the accepted offer shall be incorporated in the purchase order.
- **14.** Payment shall be made within 30 days of submission of bill & its verification by the concerned officer.
